STATEMENT OF CHANGES IN ACTIVITIES and SOURCES OF FINANCING *

North Clackamas County Water Commission's primary source of revenue is wholesale service charges from member agencies. The Commission is proposing a 3.42% increase in its wholesale service charge rates to ensure gross revenues are exceeding its ongoing operating requirements. Personnel services is increasing 15.3% as a result of the addition of one full-time staff as well as an increase in health insurance costs. Materials and services increases 63.7% due to a return to a "pass through" of water purchases as part of a renewed intergovernmental agreement. Excluding the new "pass through" expenditure, operational materials and services is decreasing 2.9% as a result of a projected decrease in the use of external contracted services. Capital outlay is projected to be higher than the previous year due to an increase in planned renewal and replacements. The Commission is confident it can anticipate favorable financial results and a resulting financial position in fiscal year 2023.
