## District Governance

The District is governed by a Board of Directors comprised of five community members elected to four-year terms by voters. The Board holds regular public meetings on the third Tuesday of each month beginning at 6:00 p.m. visit the website at [oaklodgewaterservices.org](http://oaklodgewaterservices.org) or call (503) 353-4227 to learn if the meeting will occur online or in-person at 14496 SE River Road, Oak Grove, OR.

## Drinking Water Services

The District provides customers safe, reliable drinking water from the Clackamas River. Customer rates fund essential services, including purchasing clean water and maintaining daily operations, and investments in infrastructure.



## Wastewater Services

The District collects wastewater from homes and businesses so the water can be cleaned and safely returned to the Willamette River. Customer rates fund essential services, including wastewater treatment, maintaining daily operation, and investments in the treatment plant as well infrastructure. Approximately 1.4 billion gallons of wastewater is cleaned and returned to the Willamette River each year.



## Watershed Protection

The District helps protect the environment by monitoring water quality in local waterways and helping to keep the Clackamas County-owned stormwater system clean. Customer rates fund watershed protection activities necessary to comply with state and federal water quality permit requirements.



## Billing Structure

The District bills are sent every other month for the two previous months' service. Bills are calculated individually and include average winter water use, fixed rates, and water meter reads for the service period provided.

Drinking water includes a service charge and a consumption charge. The consumption charge varies for each bill and is determined by reading the water meter. The wastewater rates are fixed once per year and include a fixed rate service charge, a watershed protection fee, and a rate that varies dependent on winter average water use.

Bills will fluctuate slightly depending on water consumption and will increase in summer months dependent on outdoor water use. Visit our website to see current rates and fees.
